QUESTION 1: WHAT LESSONS CAN SOUTH AFRICANS LEARN FROM BANTU STEPHEN BIKO WHO DIED FORTY YEARS AGO?

- 1.1.1 Define the concept *Black Consciousness* in your own words. (1 x 2) (2)
- 1.1.2 Using the information in the source, quote THREE components of the philosophy of Black Consciousness. (3 x 1) (3)
- 1.1.3 Explain, in your own words, how black South Africans could achieve psychological liberation. (1 x 2) (2)
- 1.1.4 Comment on the usefulness of the information in this source for a historian researching the philosophy of Black Consciousness. (2 x 2) (4)
- 1.2 Read Source 1B.
- 1.2.1 Select TWO pieces of evidence from the source that suggest that the police regarded Steve Biko as a threat. (2 x 1) (2)
- 1.2.2 Why, according to the information in the source, did the police decide to arrest Steve Biko outside Grahamstown in 1977? (1 x 2) (2)
- 1.2.3 Using the information in the source and your own knowledge, explain what motivated the doctors to make false diagnoses regarding how Biko died. (2 x 2) (4)
- 1.2.4 Quote THREE words from the source that describe how Biko died on 12 September 1977. (3 x 1) (3)
- 1.3 Consult Source 1C.
- 1.3.1 Explain why you think Black Consciousness activists decided to carry this poster. (1 x 2) (2)
- 1.3.2 Comment on the significance of the following in the poster:
- (a) The clenched fists (1 x 2) (2)
- (b) The broken chain (1 x 2) (2)

- 1.4 Use Source 1D.
- 1.4.1 Why do you think Allister Sparks was determined to find out how Steve Biko was murdered? (2 x 2) (4)
- 1.4.2 Name TWO ways in the source that show how Helen Zille went about gathering information regarding Biko's murder. (2 x 1) (2)
- 1.4.3 Comment on how Jimmy Kruger and Dr Hersch differed regarding the circumstances under which Biko died. (2 x 2) (4)
- 1.5 Compare Sources 1B and 1D. Explain how the information in Source 1B supports the evidence in Source 1D regarding the death of Steve Biko. (2 x 2) (4)
- 1.6 Using the information in the relevant sources and your own knowledge, write a paragraph of about EIGHT lines (about 80 words) explaining the lessons that South Africans can learn from Bantu Stephen Biko who died forty years ago. (8) **[50]**

QUESTION 2: HOW DID THE TRUTH AND RECONCILIATION COMMISSION (TRC) DEAL WITH THE MURDER OF POLITICAL ACTIVISTS, SUCH AS AHMED TIMOL?

- 2.1.1 What happened to Ahmed Timol on 22 October 1971? (1 x 1) (1)
- 2.1.2 Quote TWO pieces of incriminating evidence that police found in the boot of Ahmed Timol's car. (2 x 1) (2)
- 2.1.3 What evidence in the source suggests that Ahmed Timol was tortured while in police custody? List THREE pieces of evidence. (3 x 1) (3)
- 2.1.4 Explain to what extent you would consider the evidence given by police interrogators regarding how Timol was killed, to be reliable. (2 x 2) (4)
- 2.2 Consult Source 2B.
- 2.2.1 Why, according to the source, was the TRC established? (1 x 2) (2)
- 2.2.2 Define the term *amnesty* in the context of the TRC. (1 x 2) (2)
- 2.2.3 Name the following leaders of the TRC:
- (a) The chairperson (1 x 1) (1)
- (b) The deputy chairperson (1 x 1) (1)
- 2.2.4 Using the information in the source and your own knowledge, explain why the democratic government opted for restorative justice rather than retributive justice. (2 x 2) (4)
- 2.3 Read Source 2C.
- 2.3.1 Explain why you think this photograph was taken. (2 x 2) (4)
- 2.3.2 Comment on why Hawa Timol decided to appear before the TRC. (2 x 2) (4)
- 2.4 Compare Sources 2B and 2C. Explain how the information in Source 2B supports the evidence in Source 2C regarding how the TRC dealt with the murder of Ahmed Timol. (2 x 2) (4)

- 2.5 Study Source 2D.
- 2.5.1 Why, according to the evidence in the source, did the NPA decide to reopen the inquest into how Ahmed Timol was murdered? (1 x 2) (2)
- 2.5.2 Explain why you think Cajee decided to pay tribute to Hawa Timol. (2 x 2) (4)
- 2.5.3 Comment on what you think was implied by the statement, '... the inquest would set a precedent (example) for other families to follow', in the context of the TRC hearings. (2 x 2) (4)
- 2.6 Using the information in the relevant sources and your own knowledge, write a paragraph of about EIGHT lines (about 80 words) explaining how the TRC dealt with the murder of political activists, such as Ahmed Timol. (8) **[50]**

QUESTION 3: HOW WAS SOUTH AFRICA'S POULTRY INDUSTRY AFFECTED BY GLOBALISATION?

Study Sources 3A, 3B, 3C and 3D and answer the questions that follow.

- 3.1.1 Define the term *globalisation* in your own words. (1 x 2) (2)
- 3.1.2 Quote THREE ways from the source that suggest that globalisation affected the physical wellbeing of societies in the world. (3 x 1) (3)
- 3.1.3 Using the information in the source and your own knowledge, explain why internationalism was regarded as more successful than nationalism in the context of globalisation. (2 x 2) (4)
- 3.1.4 Identify the TWO international monetary (financial) institutions that supported the process of globalisation. (2 x 1) (2)
- 3.1.5 Why, according to the information in the source, did monetary institutions decide to pressurise South Africa to remove its trade barriers? (2 x 1) (2)

3.2 Study Source 3B.

- 3.2.1 What prompted South African poultry producers to join the anti-globalisation protests? (1 x 1) (1)
- 3.2.2 Explain why European poultry producers criticised South African poultry farmers about how they conducted their business. (2 x 2) (4)
- 3.2.3 Why, according to the source, did the South African government decide to protect the local poultry industry? (2 x 1) (2)

3.3 Consult Source 3C.

- 3.3.1 Explain the messages that are conveyed in the cartoon. Use the visual clues in the source to support your answer. (2 x 2) (4)
- 3.3.2 Comment on why you think the cartoonist decided to portray 'CHEAP IMPORTS' as larger than 'LOCAL PRODUCERS'. (2 x 2) (4)

3.4 Compare Sources 3B and 3C. Explain how the information in Source 3B supports the evidence in Source 3C regarding the crisis that South Africa's poultry industry faced. (2 x 2) (4)

- 3.5 Read Source 3D.
- 3.5.1 Name the union that pleaded with the South African government to tighten regulations regarding cheap poultry imports. (1 x 1) (1)
- 3.5.2 Which country, according to the source, was South Africa's major competitor regarding poultry imports? (1 x 1) (1)
- 3.5.3 Explain how the DTI and DAFF attempted to protect South Africa's poultry industry. (2 x 2) (4)
- 3.5.4 Using the information in the source and your own knowledge, explain why a historian would find this source useful when researching the impact that cheap imports had on South Africa's poultry industry. (2 x 2) (4)
- 3.6 Using the information in the relevant sources and your own knowledge, write a paragraph of about EIGHT lines (about 80 words) explaining how South Africa's poultry industry was affected by globalisation. (8)
